Reference of RPTs in different laws, why are RPTs regulated, company law, examples of ‘Related Parties’ in relation to TML Co., prescribed transactions, and important checkpoints in laws. He also took some case studies.

CS Sheetal Joshi told the meaning of governance and corporate governance. She also guided about components of good governance, technology introduced to regulate insider trading, depositories in India, technology introduced to regulate investor grievances, technology to regulate sustainable growth, need for automation, transformation that upskilling and automation can achieve & key takeaways.

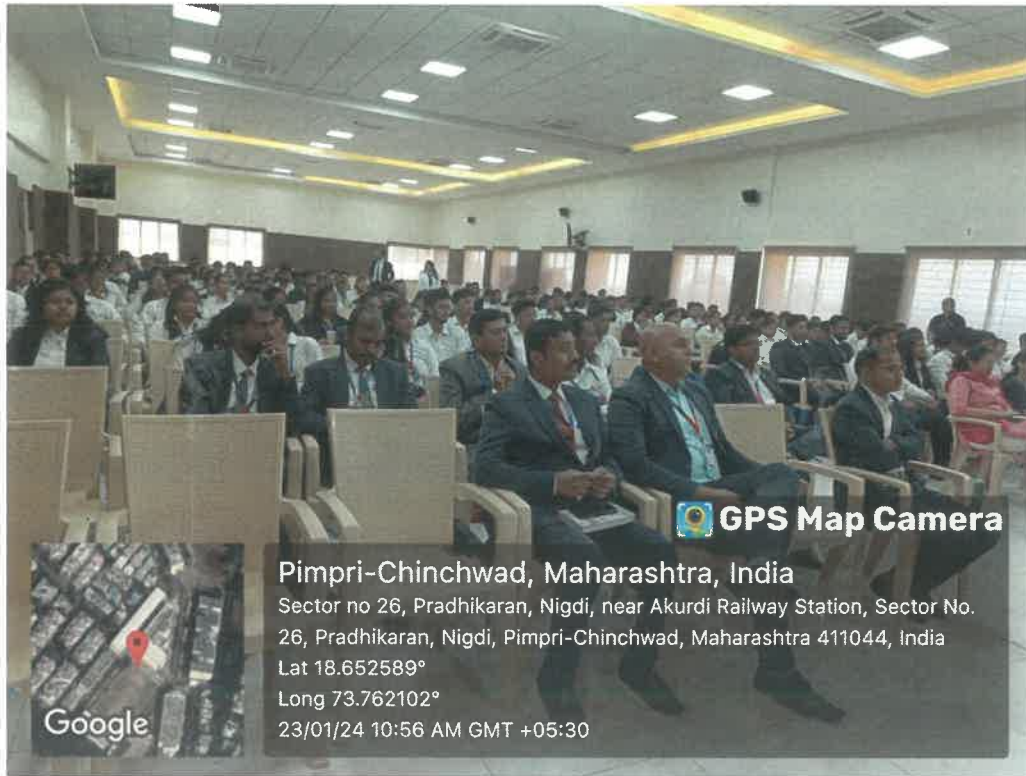
